- Bidders are invited for the Provision of Website Maintenance for the Medicines Regulatory Authority (BoMRA) for a period of three (3) years.
- The Procuring Organization is Medicines Regulatory Authority (BoMRA) and this tender is an open domestic tender, i.e. all qualifying companies domiciled in Botswana are eligible to tender.
- Bidders must, in order to be considered for the award of the contract:
 - Be registered with PPRA under the relevant of
Code 120 – ICT Technical Support Services
Sub Code: 01 – System Development Services & Maintenance Services
 - Have a valid and appropriate Tax Clearance Certificate or an Exemption thereof;
 - Have an appropriate licence

1. Tender responses will be accepted from companies that BoMRA sent the electronic ITT only.
2. There will be no issuing of hard copies of ITTs to bidders.

Proof of Payment must be sent to procurement@bomra.co.bw as well as tmoruakgomo@bomra.co.bw and must be included in the Bid Responses, failing which the bid will be disqualified. The tender document will be sent to the bidders upon receipt of their proof of payment and after confirmation that funds have been received in the BoMRA Account.

BoMRA shall send the ITT document to bidders who provided proof of payment by end of day

(17:00hrs) on **07th March 2025**. No bidder's proof of payment shall be accepted after this time, and the ITT document will not be sent. Please note that the tender fee remains non-refundable and non-transferable even with this requirement.
